June 21, 2022

## Call to Order

The three hundred and sixtieth regular meeting of the Governor's Council on Alcoholism and Drug Abuse was called to order at 10:00 a.m. by Acting Chairman Neil Van Ess.

#### **Chairman's Report**

Chairman Van Ess welcomed everyone to the meeting and thanked the Council for attaining quorum consistently since January. He announced that the Council would be voting on the FY23 County Plan resolutions and acknowledged the good work of the County Coordinators and asked Executive Director Celina Levy to read the names of those who were present.

# <u>Presentation: "Understanding and Addressing Substance Abuse in the LGBTQIA+ Community"</u>

JP Pedoto, Pride+ Program Coordinator and Clinician at Family Connections gave an overview of the Pride+ program and the substance abuse challenges that the LGBTQIA+ community can face.

Pride+ is a program that is free of charge for middle and high school youth and their families and is funded by the Healthcare Foundation of New Jersey. Services include individual, group and family counseling, middle and high school education and support groups, parent education and support groups, field trips, trainings and presentations.

Approximately 20-30% of the LGBTQIA+ community abuses substances and this may be attributed to the Minority Stress Theory which suggests that members of the community experience a unique and chronic stress due to discrimination or harassment. Mr. Pedoto stressed

that more treatment options are needed that are LGBTQIA+ specific as well as affirming treatments.

#### **Executive Director's Report**

Executive Director Celina Levy thanked the Council members once again for attaining quorum consistently since January. She also expressed her gratitude to the GCADA Review Team, County and Municipal Coordinators and the GCADA Alliance Unit for their hard work.

Ms. Levy shared that two new members, John Armato and Eileen Fishman, had been appointed to the Council and would be attending next month's meeting.

Ms. Levy also shared that she and Deputy Director Rebecca Alfaro continue to work with the Governor's office on options for alternative funding streams and long-term sustainability for the program and also continue to be engaged in collaborative planning for the state's harm reduction efforts.

Director of Prevention and Planning, Sara Thode informed the Council that the Alliances had participated in another webinar by the Prevention Technology Transfer Center on June 9<sup>th</sup>. She also shared that AGATE is expected to be in production for the FY24 grant cycle and that the Alliances would be trained on how to use the new online grant management system.

Ms. Levy thanked the Council members for their input and support, the County Coordinators and Alliances for their good work despite the continued challenges and GCADA staff for their strong work ethic, and to Neil Van Ess for his ongoing leadership.
